Mr. Merrill asked for a report from the Planning Department. Mr. Ferguson gave the report and stated that because the lot is currently two different zoning classifications, in a preliminary meeting with the applicant staff encouraged the applicant to rezone the rear LM portion to BG to create a more uniform condition. Staff recommendation of the rezoning is for approval.

Mr. Merrill asked if the applicant was present. Mr. Gregory J. Dechko gave the presentation on behalf of the applicant. Mr. Dechko stated that the applicant, who is a division of the Lawrenceville Church of God, desires to locate a church on the property and plans to make significant upgrades to the building and property pursuant to the zoning ordinance requirements. Mr. Dechko reiterated that the rezoning request was in response to the Planning Department request.

Mr. Merrill asked if there were any questions from the Commissioners. The Commissioners asked several questions. Mr. Merrill asked about the days and times of services, the size of the congregation and if there was adequate parking on the property. The applicant stated that the congregation was around 40 families and the current parking count was 135 which met the City requirement.

Mr. Merrill then asked if there was anyone in opposition to the rezoning. There was none. Mr. Merrill then called for a motion. Mr. Strickland made a motion to approve. Mr. Roberts seconded the motion. The motion carried. 4-0

Mr. Merrill asked if there were any reports from staff or the commissioners. Mr. Ferguson stated that there had been no applications received in the Planning Department and there would be no February meeting unless there was a City Council initiated item.

Mr. Merrill asked that the election of Planning Commission officers be placed on the agenda of the next meeting.
