EZZARD WELL #3 TREATMENT FACILITY**

Sealed bids will be received by the City of Lawrenceville, Georgia, for furnishing all materials, labor, tools, equipment, and any other miscellaneous items necessary for the construction of the Ezzard Well #3 Treatment Facility in the City of Lawrenceville, Georgia.

Bids will be received at the Lawrenceville City Hall, 70 South Clayton Street, Lawrenceville, GA 30046, until 10:00 A.M. on March 18, 2010. Any bid received after said time and date of bid opening will not be considered by OWNER. Bids will be publicly opened and read aloud at this time and location. All bids will be evaluated by OWNER and the project will be awarded, if it is awarded, within ninety (90) days of the bid opening.

The Project consists of, but is not limited to the following major elements:

Installation of OWNER's package uranium removal unit to include construction of a building to house the package treatment unit, booster pump, yard piping interconnections with existing Ezzard Well #3 pump house and raw water transmission main, telemetry and electrical connections and all appurtenances.

Time of completion for all work associated with this project shall be one hundred twenty (120) consecutive calendar days from the date of a written "Notice to Proceed" from OWNER.

A list of persons who purchased Contract Documents from Precision Planning, Inc. will be available from the Engineer ONLY through facsimile transmission and/or U.S. Mail.

OWNER requires a bid bond* or a certified cashier's check in the amount of five percent (5%) of the total bid to be enclosed with the bid at the time of bid opening. Cashier's check will be made payable to the City of Lawrenceville, Georgia.

The successful bidder will be required to furnish OWNER with Insurance, Workman's Compensation Insurance, and Performance and Payment Bonds* in the amount of one-hundred percent (100%) of the total bid.

Each bid must be submitted in a SEALED ENVELOPE, addressed to the OWNER. Each sealed envelope containing a Bid must be plainly marked on the outside as, "Bid for the City of Lawrenceville Ezzard Well #3 Treatment Facility" **and be labeled with the BIDDER'S State of Georgia Utility Contractor License Number**. If bid is forwarded by mail, the sealed envelope containing the Bid must be enclosed in a separate mailing envelope to the attention of the OWNER at the address previously given.

All Bids must be made out on the bid form of the type bound in the Contract Documents, in accordance with the instructions in the Information for Bidders. No interlineation, additions, or deletions shall be made in the proposal form by the BIDDER.

Any and all Bids received without the aforementioned qualification criteria enclosed, will be returned to the BIDDER.

CONTRACTORS and SUBCONTRACTORS bidding on this Project will be required to comply with all Federal, State, and local laws.

OWNER reserves the rights to waive any informalities or to reject any or all Bids, to evaluate Bids, and to accept any Bid which in its opinion may be in the best interest of the OWNER. No Bid will be rejected without just cause.

A Pre-Bid Conference will be held at 2:00 P.M., March 2, 2010, at the Lawrenceville City Hall 70 South Clayton Street, Lawrenceville, Georgia 30046, telephone no. (770) 963-2414. Prospective Bidders are encouraged to attend this conference to discuss and clarify questions regarding the Bid Documents.

Successful Bidder will be required to perform WORK as the Prime Contractor. WORK performed by Prime Contractor shall be at a minimum 60% of the contract value.

No BIDDER may withdraw his bid within the time limit specified in the Instruction to Bidders (Section 00100).
